



2024 KEN ROHRENBACH SCHOLARSHIP APPLICATION LAKE COUNTY JOB SERVICE EMPLOYERS' COMMITTEE

PURPOSE: This scholarship program is designed to provide financial assistance to high school seniors who want to further their knowledge, skills, and abilities by engaging in a course(s) of study at the post high school level. This advanced training is not limited to traditional college or university course work and can include any trade or technical school.

AWARD: The Lake County Job Service Employers' Committee (JSEC) will provide a \$1,000 scholarship to a graduating high school senior. The scholarship will be awarded by the end of May each year.

APPLICANT ELIGIBILITY:

1. Must be a 2024 graduate of a high school or home school in Lake County.
2. Must intend to enroll in a post high school education program. It is the intention of Lake County Job Service Employers' Committee that the funds be used for purchase of educational supplies or to assist with tuition.
3. Selection will be based upon financial need, GPA, record of community service, and evidence of determination and potential to succeed in a higher education program in a career field after completing college or trade school. Your academic achievement in high school will be considered not by GPA alone, but by the number and level of subjects taken.

The applicant must include documentation or verification of the cost of the course of study with the scholarship application. **It is your responsibility to ensure the application is complete. If an incomplete application is submitted, it will not be considered.** JSEC members will make up the selection committee.

Applications must be submitted to Job Service Polson. The application deadline is **Friday, March 1, 2024 at 5:00 pm.** Please drop off or mail your application to: Job Service Polson, Attn: Kristopher Schock, 417 B Main Street, Polson, MT 59860. If you cannot mail your application, you may put it in the drop box, located to the left of the main front door. REFERENCES: Please provide references from **TWO** individuals who know your abilities (examples: employer, teacher, school counselor, pastor, etc.). **The references must complete the attached Reference Forms and drop them off or mail them directly to the Job Service Polson at the above address by March 1, 2024. They are not to return the forms to you. References received after March 1, 2024 and/or included with the scholarship application will NOT be considered.**
